Administrative Updates



Data Collection Forms and Performance Measures

- Slightly updated DGIS forms roll out in May 2023
<https://mchb.hrsa.gov/data-research/discretionary-grants-information-system-dgis>
 - Improved numerator/denominator definitions
 - Standardizing terms for use throughout
 - Clarifying items that were sources of confusion
 - Updated benchmark data sources and citations as related to the significance of each measure.
- More significant changes to come in FY 2024
 - Based on grantee input and review of guidelines



Multi-factor Authentication

HRSA is implementing “Two-Factor” authentication for the Electronic Handbooks (EHBs) to increase security.

- All existing Grantee users will have to establish their credentials in Login.gov
- All prospective users will have to establish their credentials in Login.gov
- OIT is conducting login.gov testing in late April
 - 6 grantees volunteered to participate
- Planned rollout: **May 26, 2023**

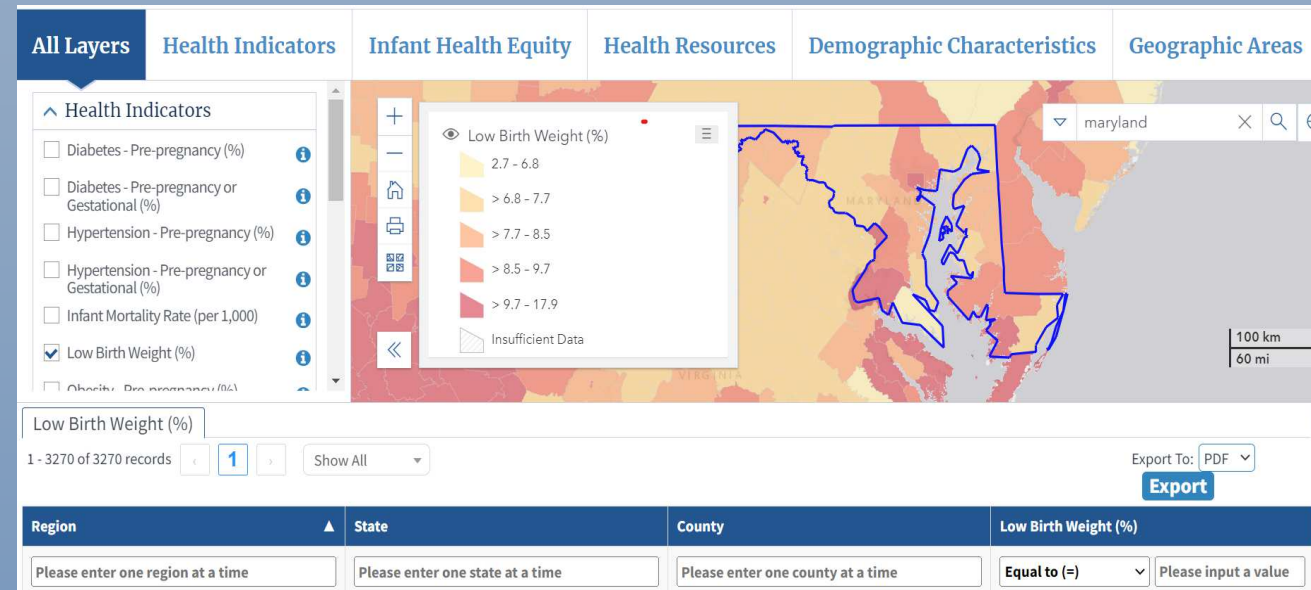

 - What strategies and activities were effective in addressing health outcomes
 - Where there are opportunities for improvement and development
 - How to improve HS programs at the grantee and national levels
 - The value of HS programs to their communities



Examples of How Evaluation Data will be Used

- Shared with grantees through written summary materials and presentations and discussions at national and regional meetings/webinars
- Showcase grantee activities
- Inform future funding and programming
- Congressional requests

Upcoming Evaluation Activities

- Recruit up to 9 grantees to provide additional data
- Implement web-based program survey
- Conduct Case Studies with 15 grantees:
 - Web-based network survey of CAN partners
 - Semi-structured interviews with program staff
 - Web-based survey for program participants



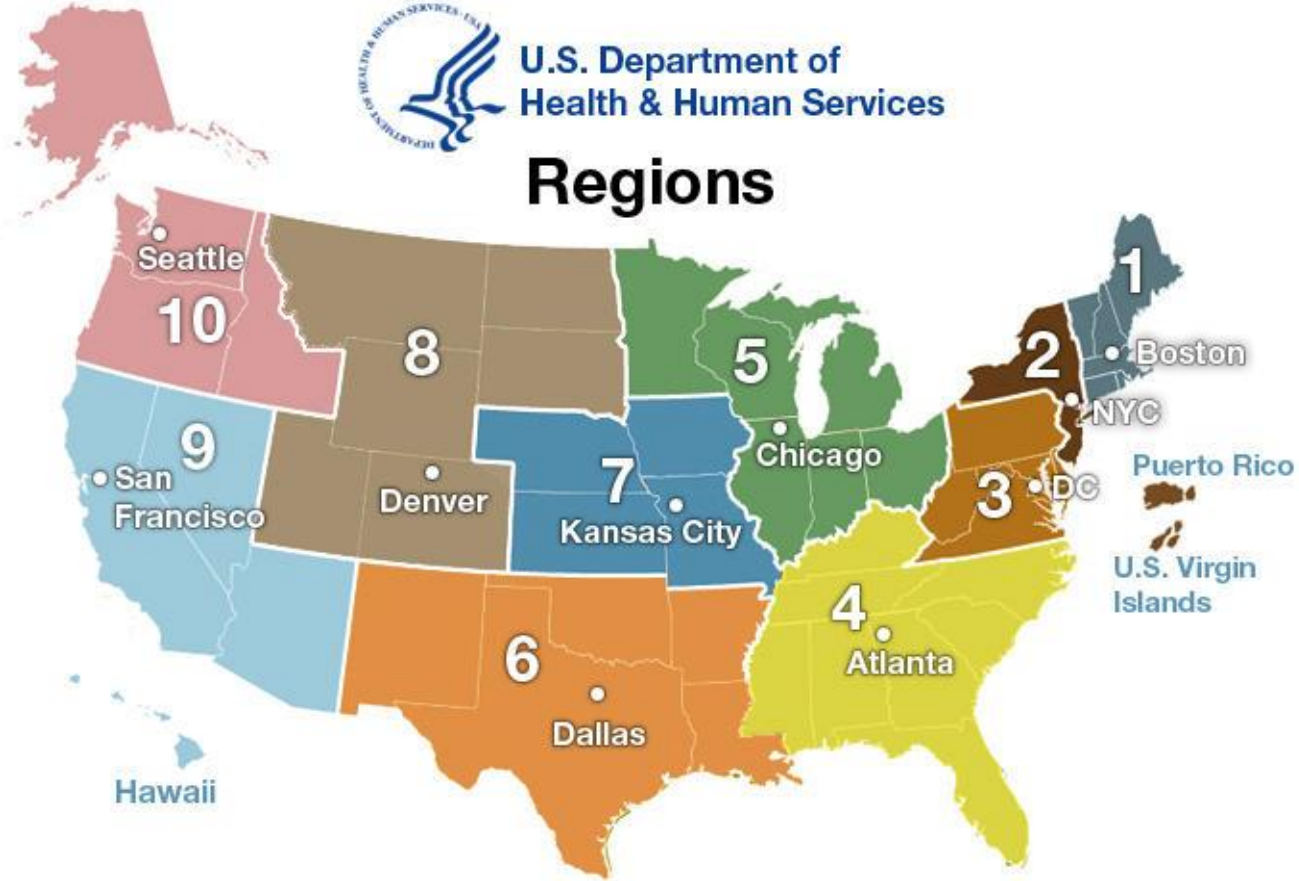

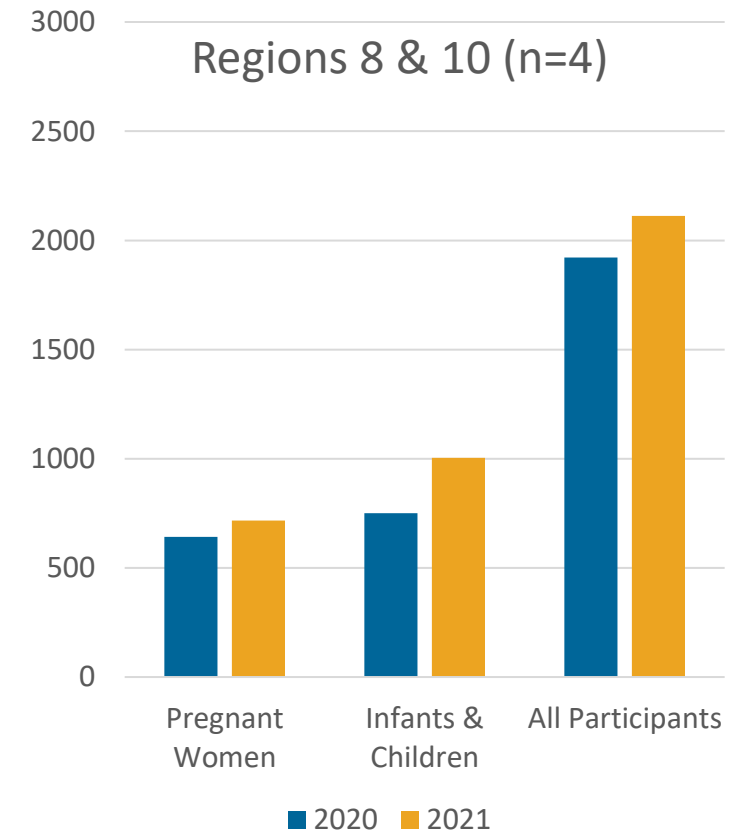

of Participants Served by Year (2020-2021)

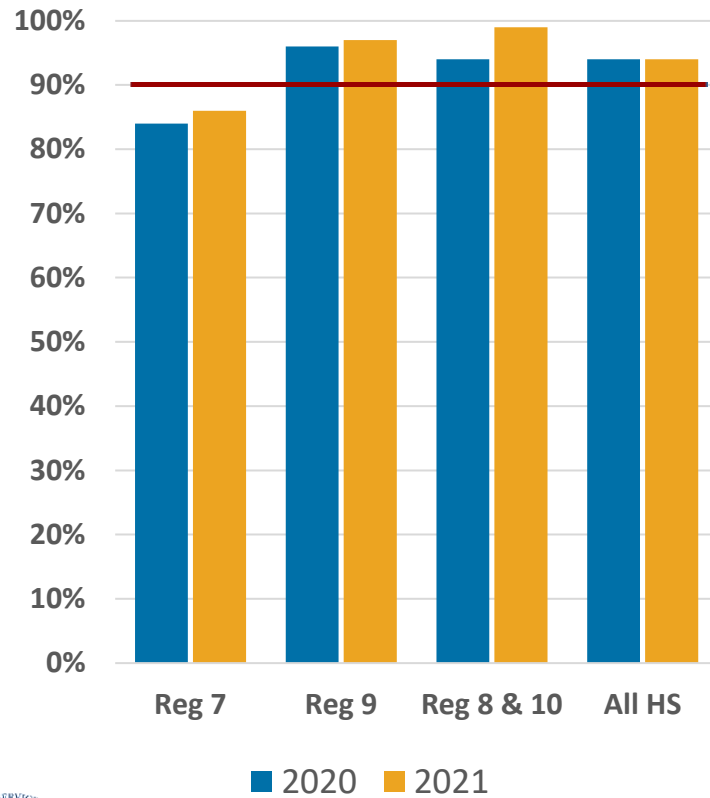

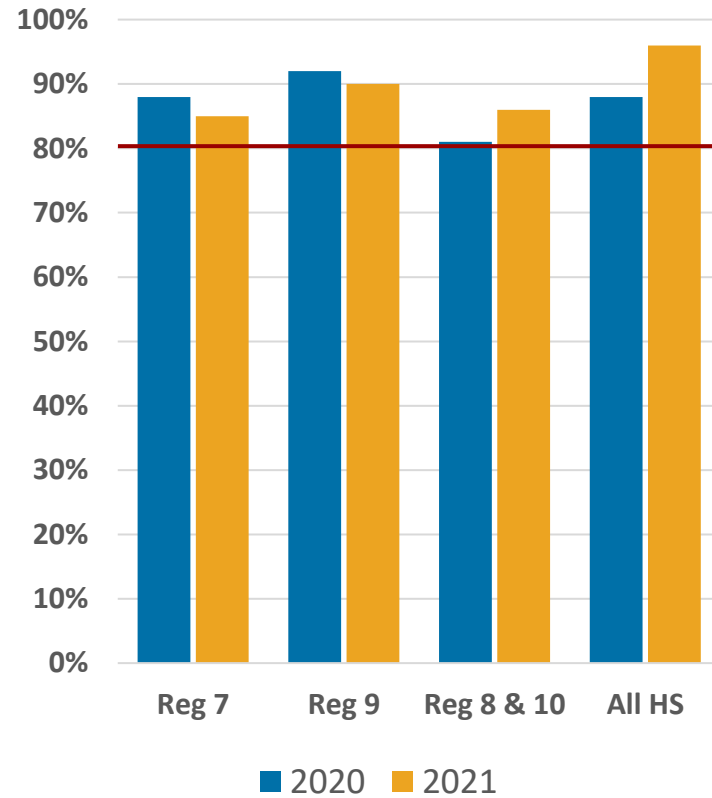


Health Care Access Trends (2020-2021)

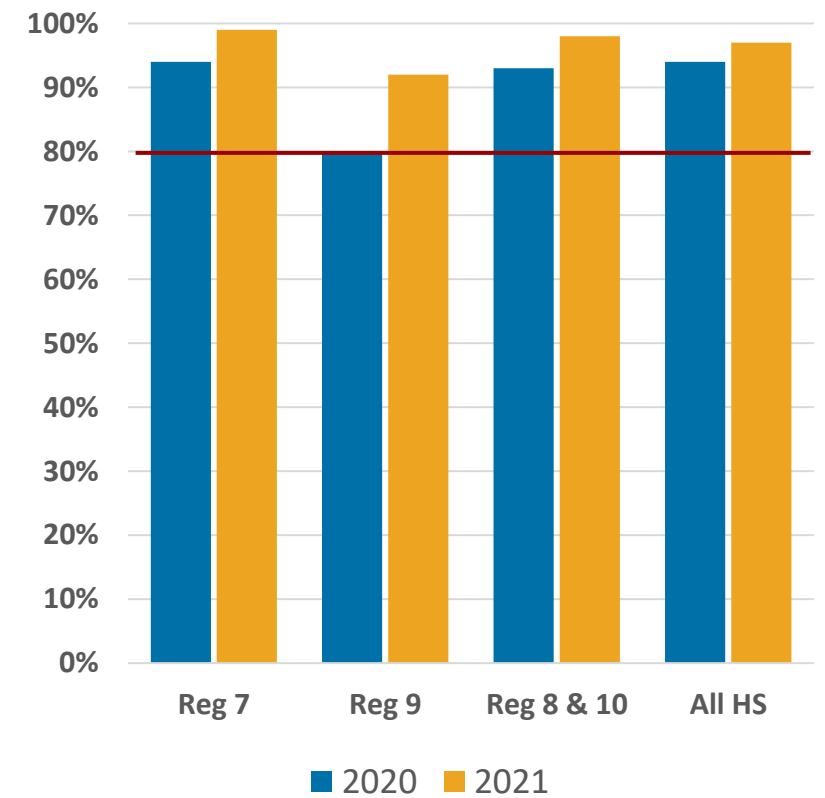
Have Insurance



Usual Source of Care - ♀

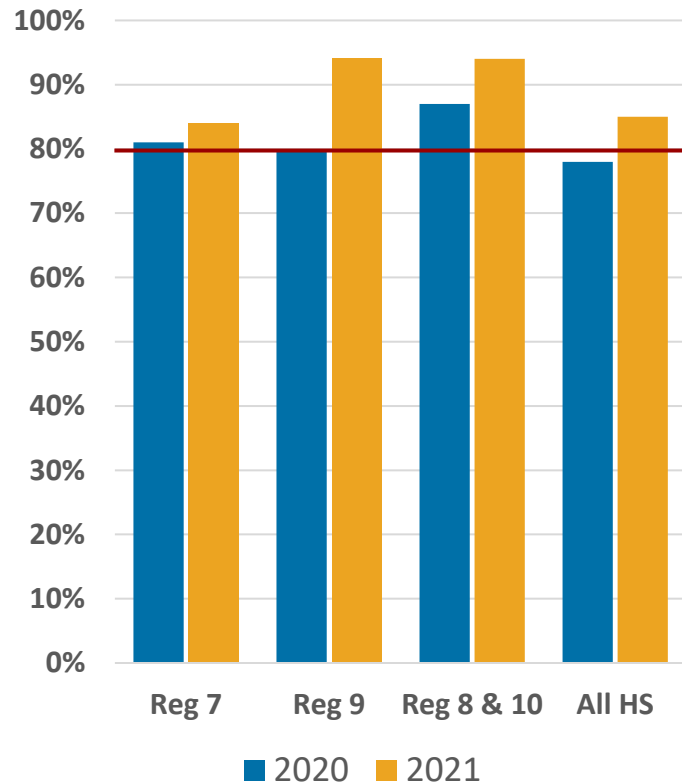


Usual Source of Care - Child

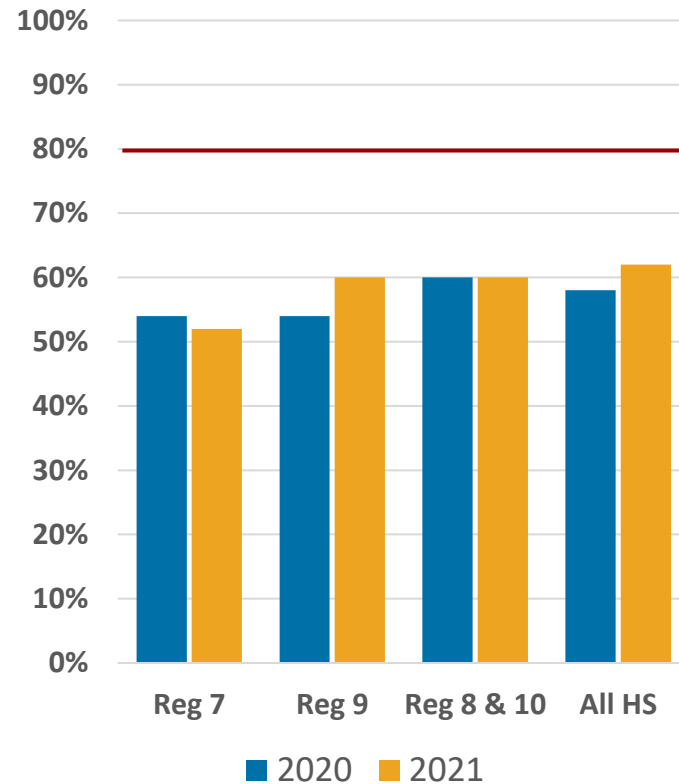


Women's Health Care Utilization Trends (2020-2021)

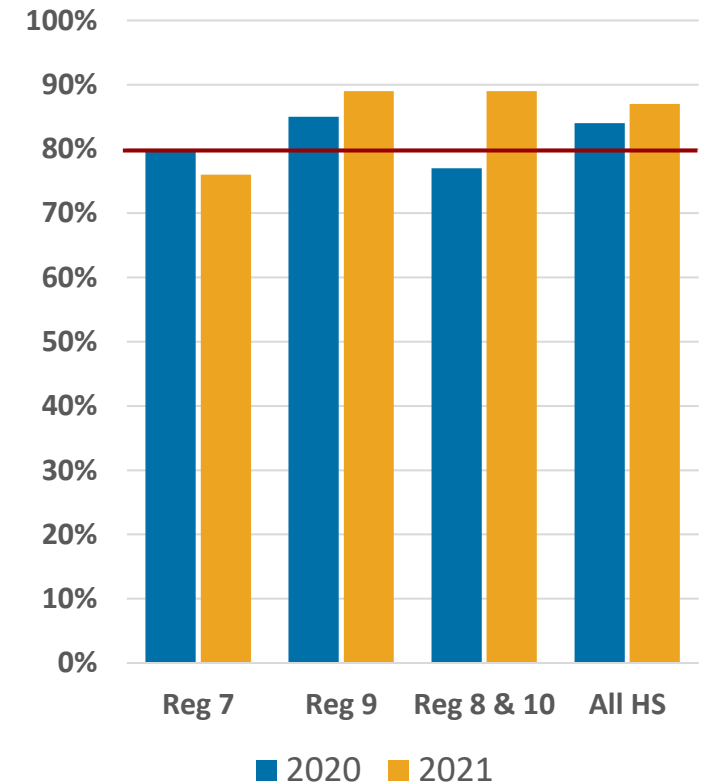
Prenatal Care - 1st Trimester



Postpartum Visit

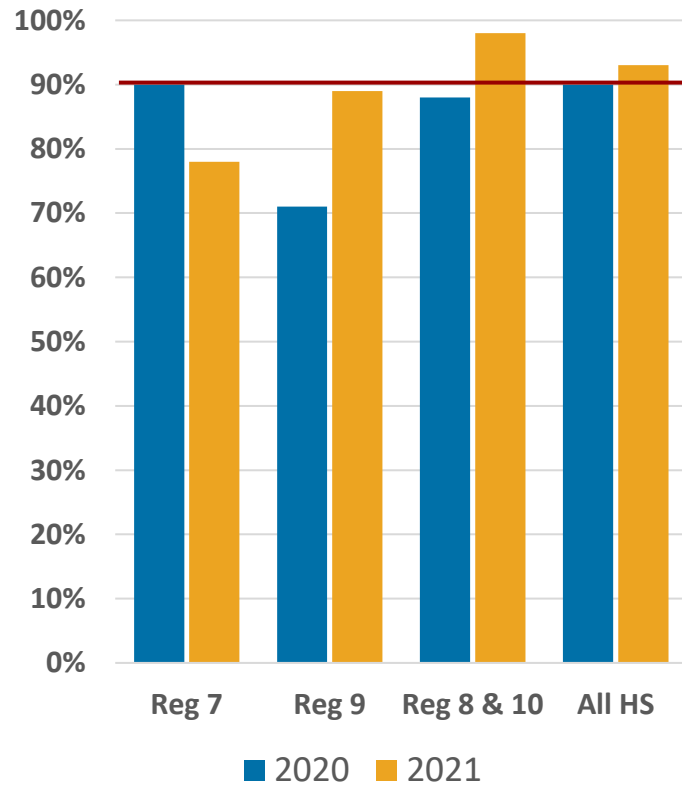


Well-woman Visit

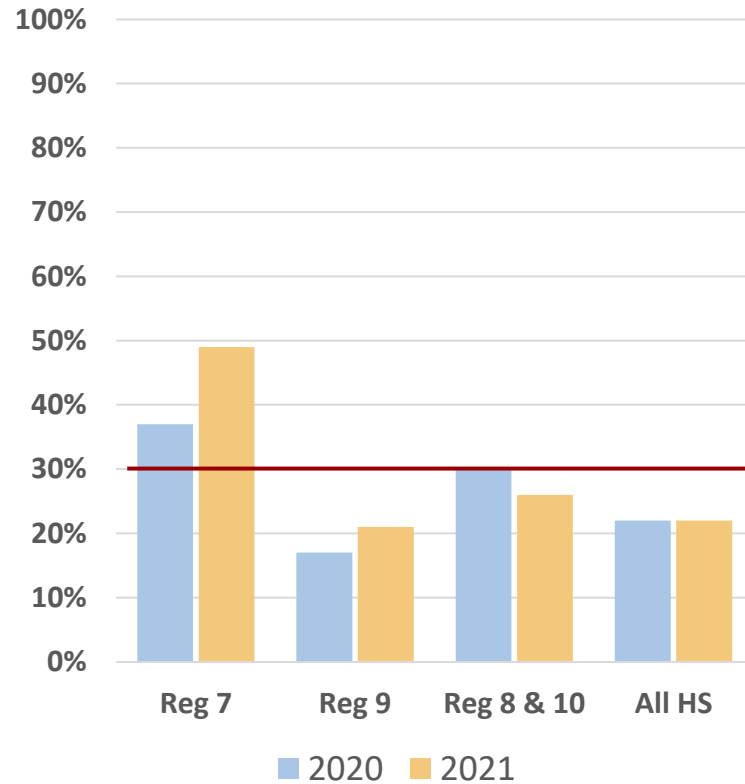


Women's Perinatal Health Trends (2020-2021)

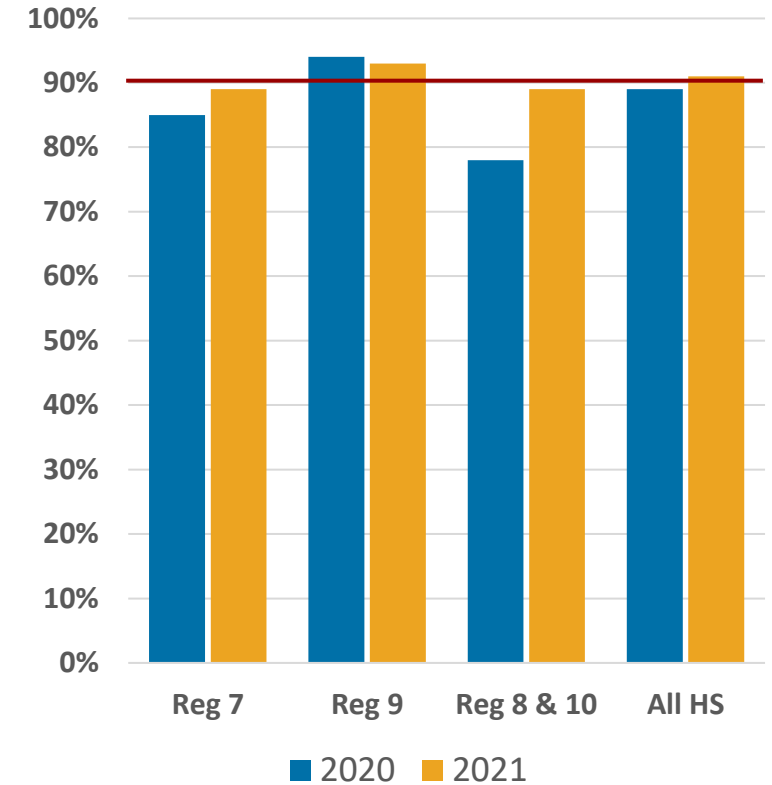
Reproductive Life Plan



Interconception Spacing (↓)

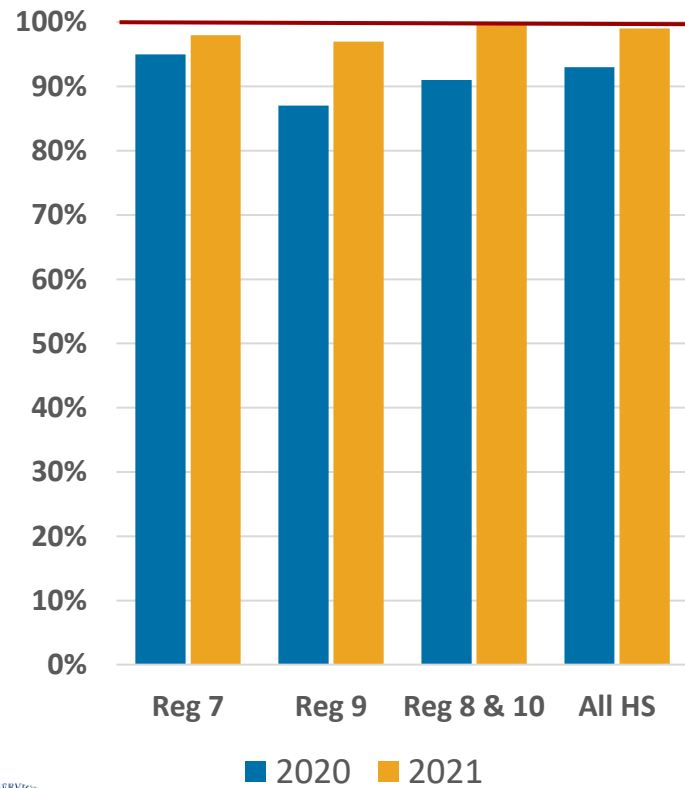


No Tobacco use in 3rd Trimester

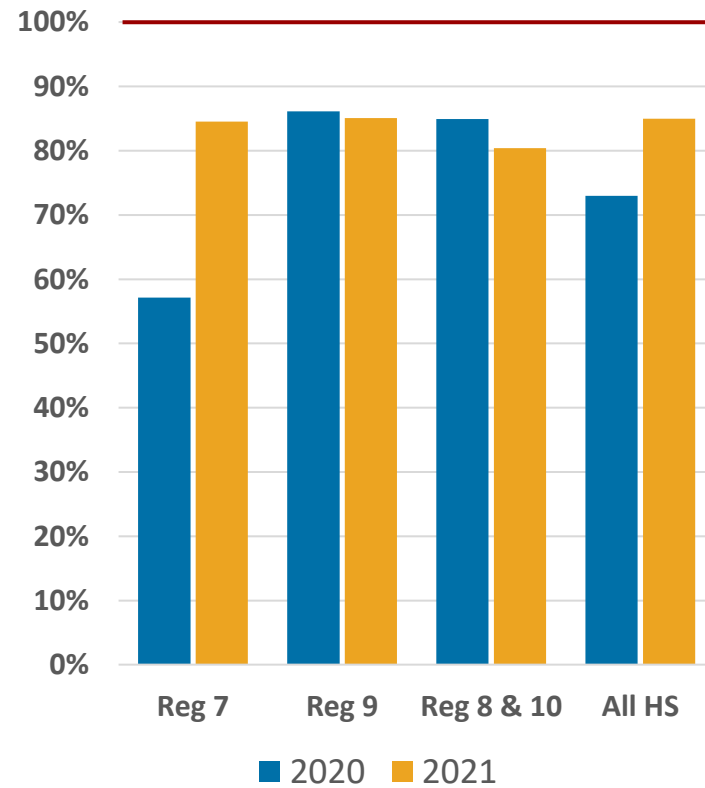

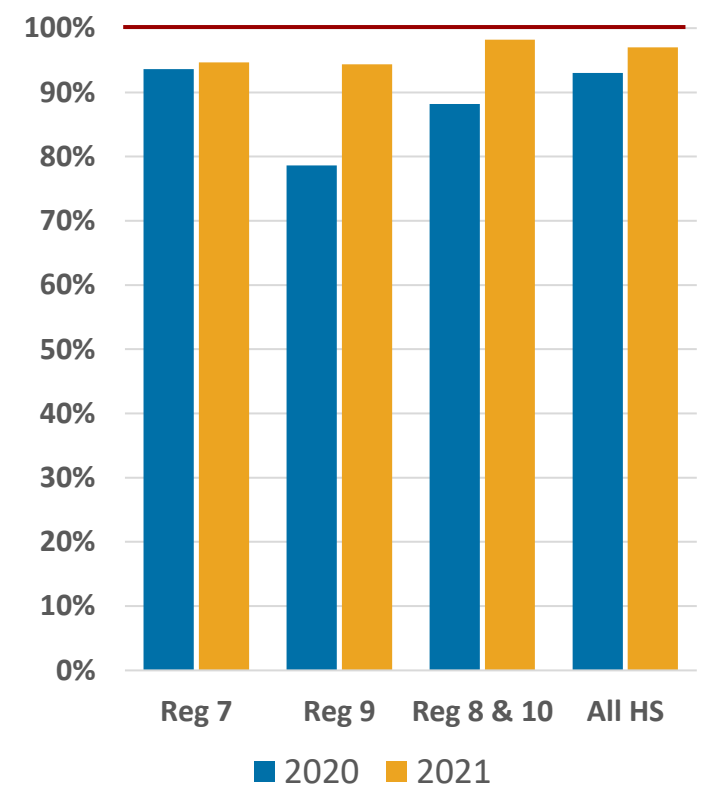
Depression Screening



Depression Referral

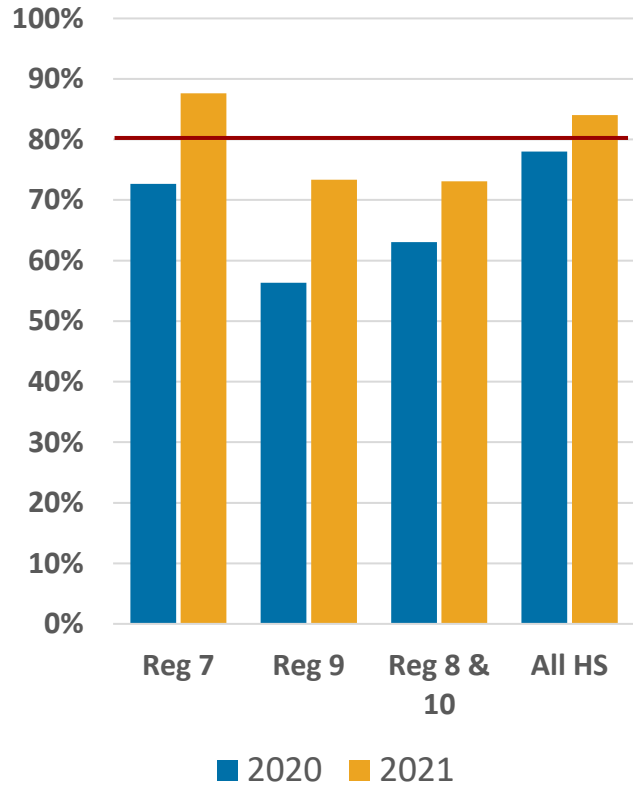


Intimate Partner Violence Screening

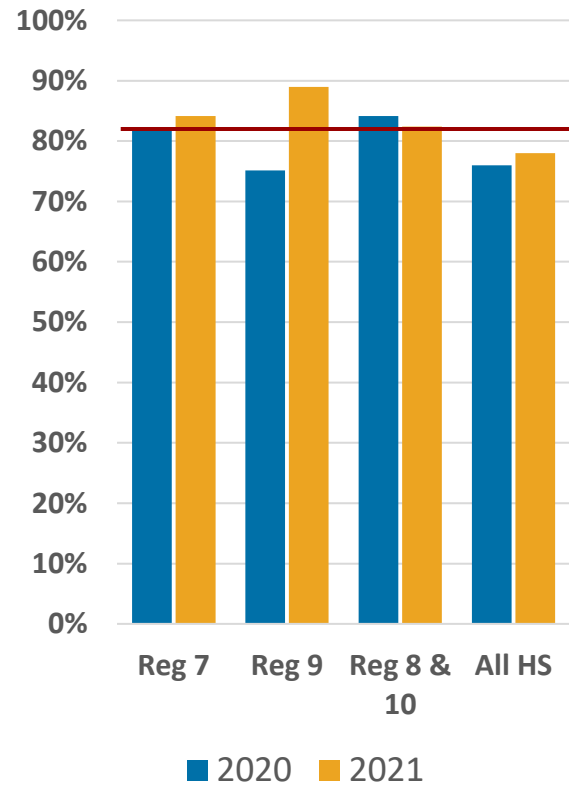


Care of Infant/Child Trends (2020-2021)

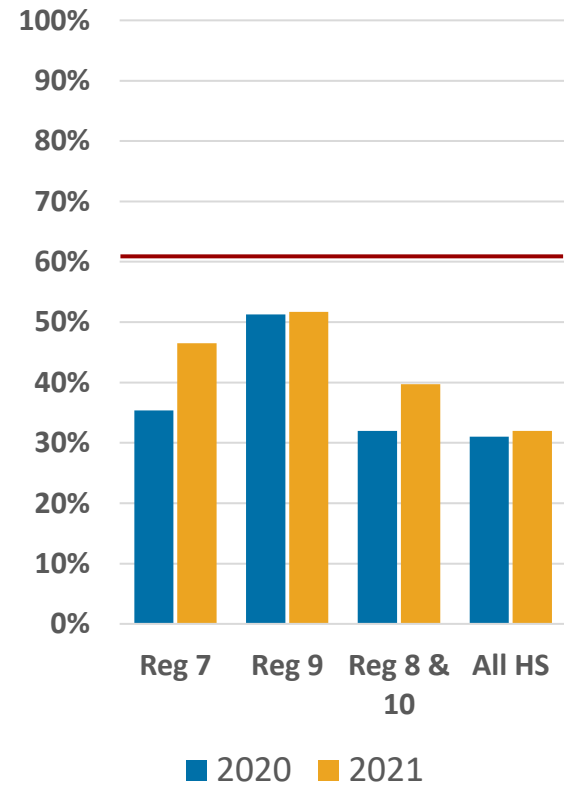
Safe Sleep



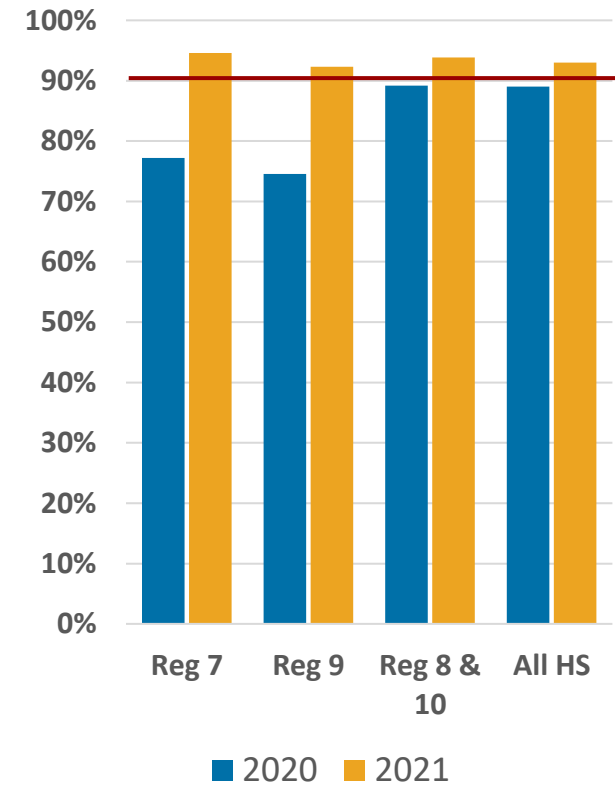
Breastfeeding - Ever



Breastfeeding - 6mo

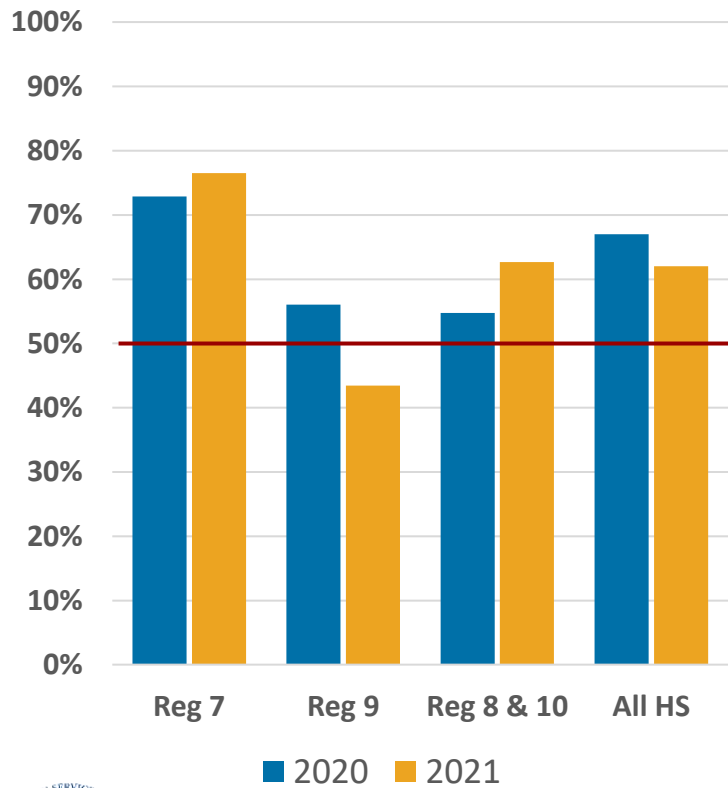

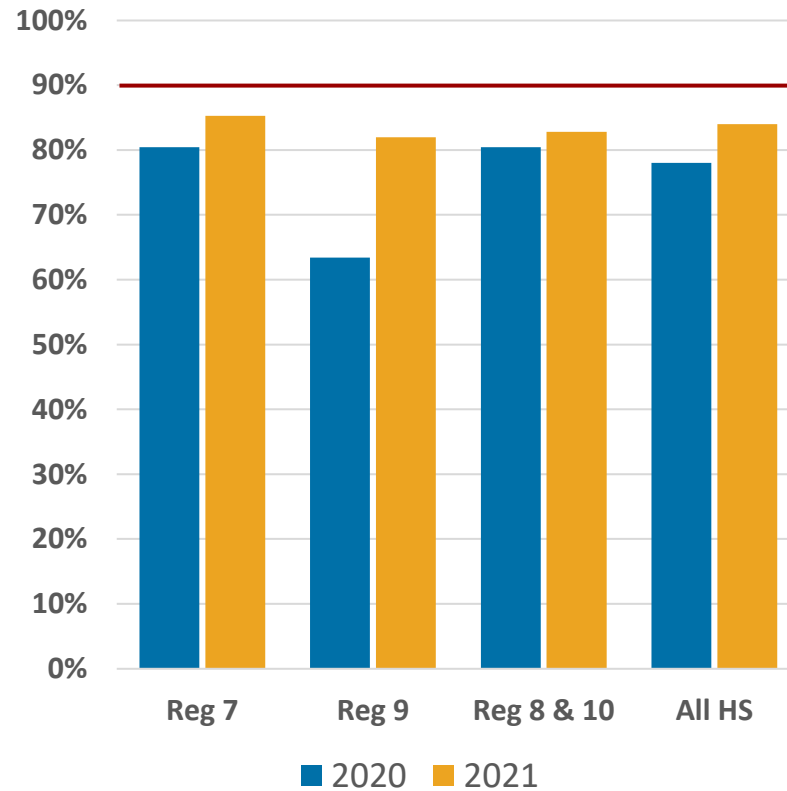


Home Life Trends (2020-2021)

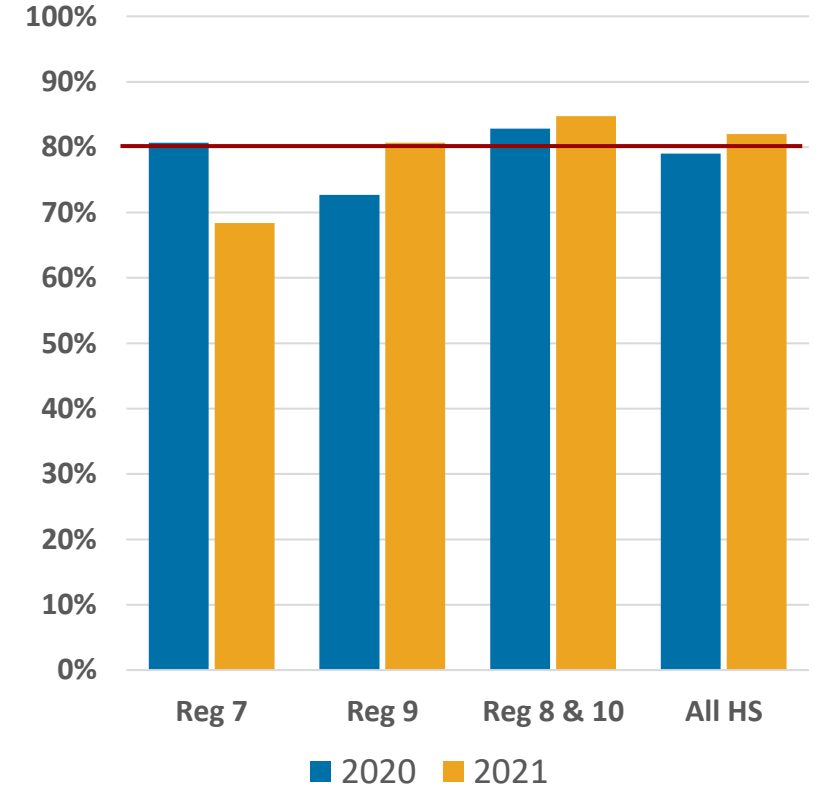

Father/Partner Involvement During Pregnancy

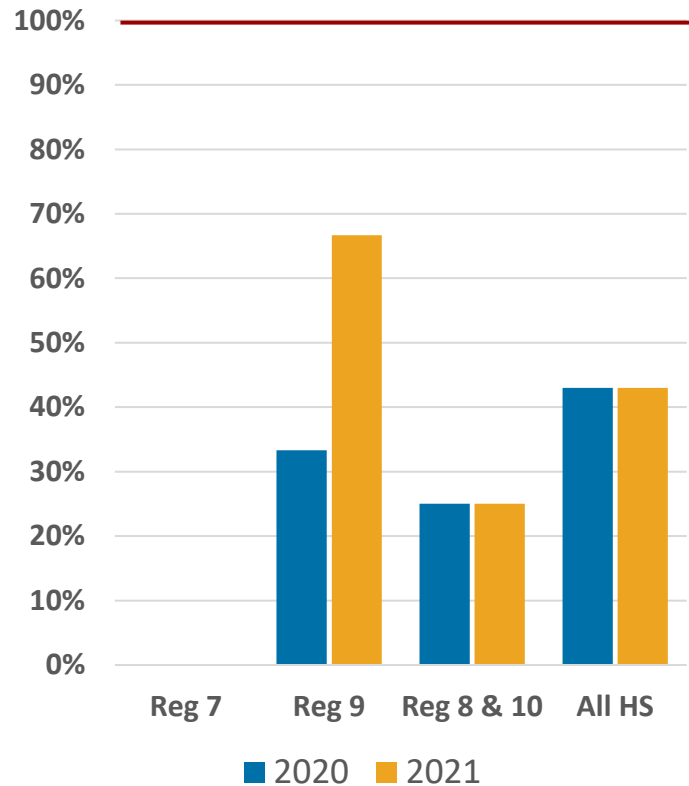


Father/Partner Involvement with Child <24mo

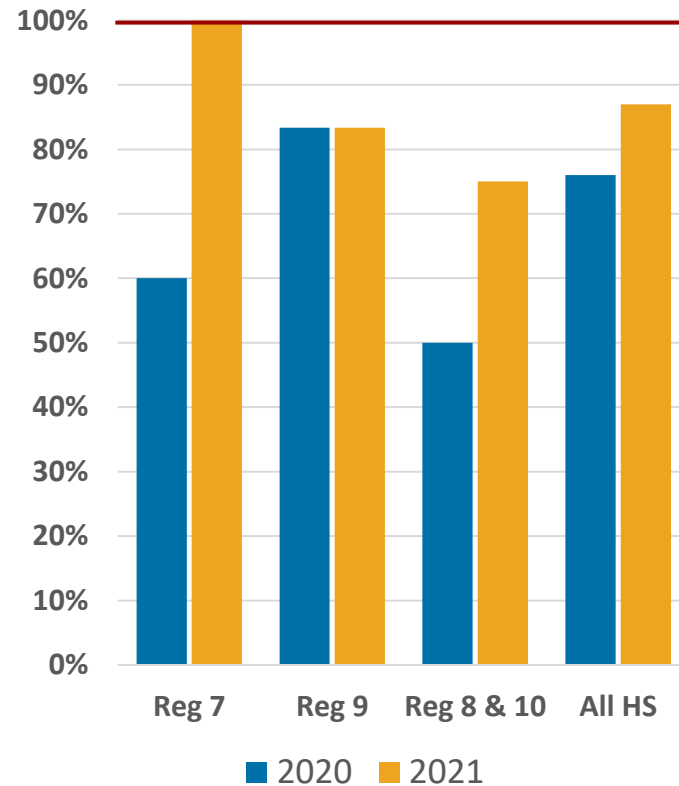

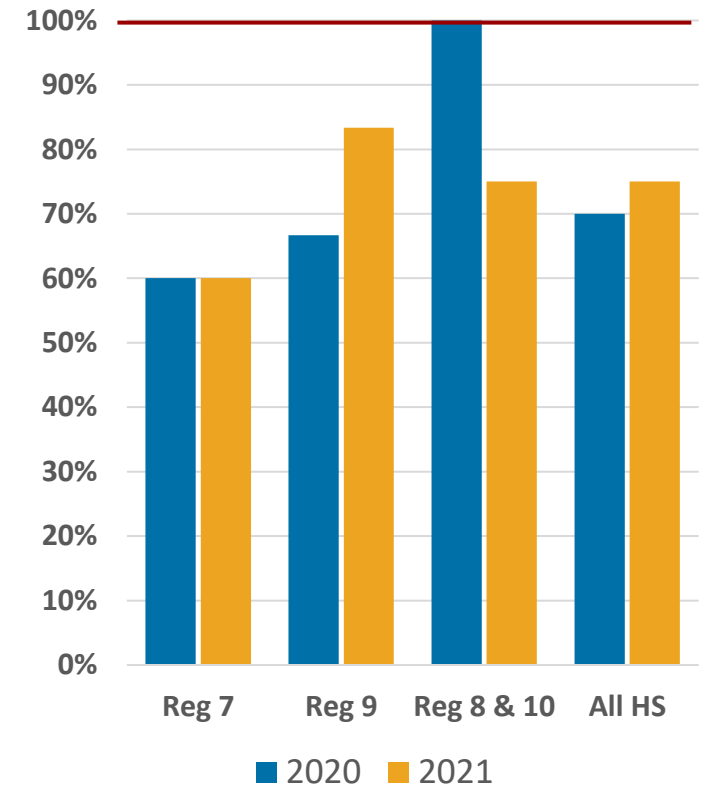

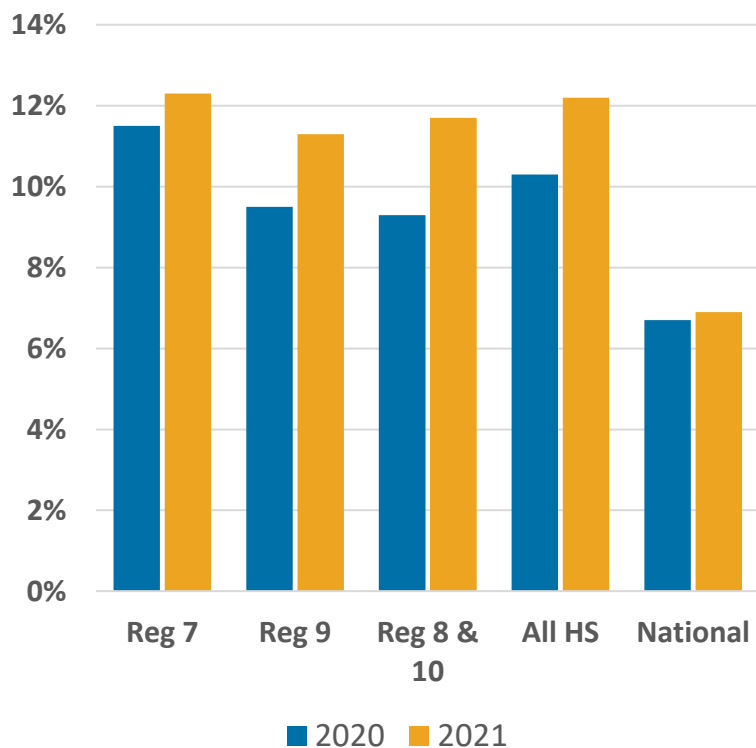

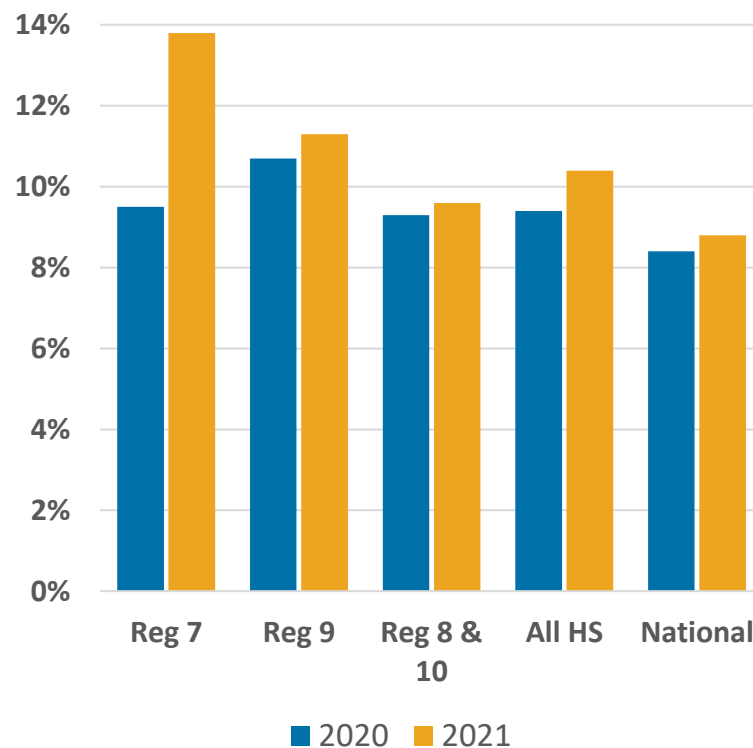


HS Birth Indicators & Infant Mortality Rates (IMR) (2020-2021)

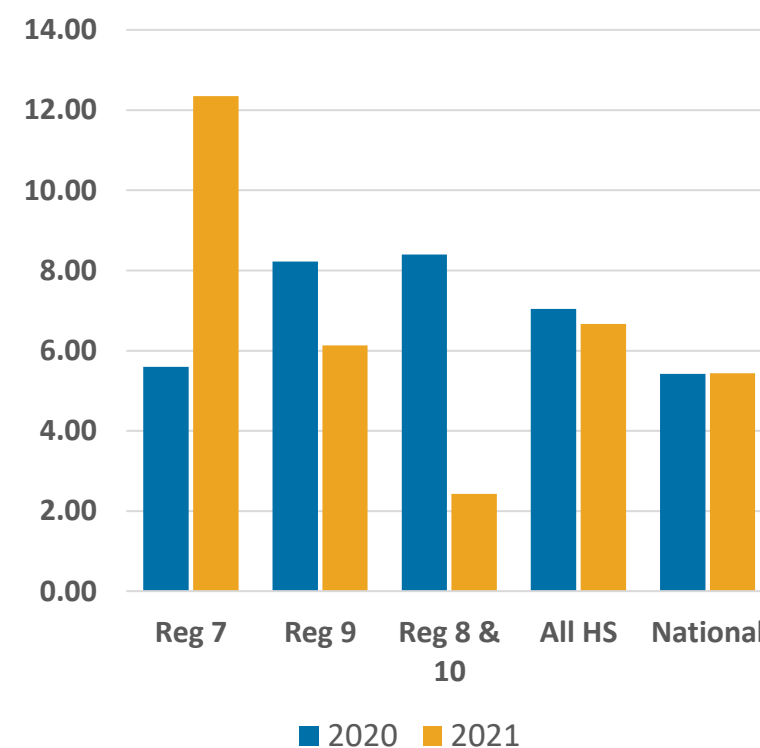
Low Birthweight
