


## Maternal Mortality

- 1,205 in 2021, up from 861 in 2020 (pandemic)
- Disproportionate:
- Hispanic women: 54 percent increase
- White women: 39 percent increase
- Black women: 26 percent increase

- 2021:
- Black: 69.9/100,000
- Hispanic: 28.0
- White: 26.6

## Answering the Challenge: Transformative Evaluation

http://zendaofir.com/the-etcetera-of-transformative-evaluation/ Stephen Porter and Donna Mertens (2019)

- underlying assumptions that rely on ethical stances of inclusion and challenging oppressive structures;
- an entry process into the community that is designed to build trust and make goals and strategies transparent;
- dissemination of findings in ways that encourage the use of results to enhance social, environmental and economic justice and human rights
- addressing intersectionality when culturally responsive, feminist, critical race, equity-focused, and Indigenous theories are relevant in the evaluation context

#### Definition of Mixed Methods

(Mertens & Wilson, 2019)

- Collect and analyze qualitative and quantitative data
- Integrate the data at various levels and stages of the study
- In a single study or a sequence of studies
- Methodologically eclectic
- Synergy between quantitative and qualitative aspects of the study

## Transformative Paradigm

Assumptions	Beliefs
Axiology	Cultural respect; promote social, environmental and economic justice & human rights; address inequities; reciprocity; resilience; interconnectedness (living and nonliving); relationships
Ontology	Multi-faceted; consequences of privilege; historically situated
Epistemology	Interactive; trust; coalition building
Methodology	Transformative, dialogic, culturally responsive, mixed methods; policy change  Mertens Healthy Start Transformative Mixed Methods



#### HEALTH DISPARITIES

- •Case: Reduce health disparities
- •How does the transformative lens open up our understanding of health disparities?



#### Relationship Building/Coalition

- identify existing community action groups and understand the history of their efforts;
- identify existing formal, informal, and potential leaders;
- identify community needs and gaps in services;
- identify community strengths and opportunities;
- understand your target population (both needs and assets) in order to improve, build, and secure project credibility within the community; and
- create a momentum for project activities by getting community input.

## Relationships with Stakeholders

Distant from, neutral, "objective" Oppressive



#### **Transformative**

- Interactive
- Culturally responsive
- Recognizing heterogeneity
- Develop trust
- Build coalitions (Fight for Fifteen)

### Versions of Reality: Ontology

Oppressive: If only they would make better choices....



#### **Transformative:**

- Poverty, unemployment, educational attainment, wealth
- Access to grocery stores and healthy food and safe places to exercise
- Stress associated with lower SES and systemic discrimination
- Residential segregation
- Access to affordable health care
- Culturally responsive health care

## Contextual Analysis



- Cultural
- Historical
- Political
- Environmental
- Legislative
- Power structures

#### **Utilization for Transformative Purposes**

- The value of sharing information throughout the course of the evaluation is emphasized to facilitate midcourse corrections if an intervention is not moving toward the desired goal.
- Planning for utilization is essential during the initial design of the study; the topic of the study must be presented to participants in order to ensure that the data are gathered and disseminated in a way that they can be used to achieve the goals of social change and social justice.
- Policy analysis and advocacy are avenues to social change from the perspective of grass-roots organizations.

#### Healthy Start Evaluation: Part of the Story

- Risky behaviors: smoking, alcohol, drugs infant mortality
- Solutions: education and employment
- Duke University: Works for White women
- 'For Black women, exposure to discrimination and racialized stress throughout the lifespan can negatively impact birth outcomes'

### Racism, discrimination, bias: Mixed Methods

- Online survey and in-depth interviews
- Racial concordance patient-healthcare provider: Connection
- Discouragement and misinformation: What works for me?
- Frustration: "did not listen"
- Excluded from decision making: My questions...
- Medical mistrust: Pressuring
- Lack of empathy: Anxiety and nervousness

# Health Disparities and History: Mixed methods

- Healthy equity and social determinants of health
- Travel course for public health students in the South
- Journals, blogs, pre and post assessments
- History: HIV, TB and sanatoriums, disasters (hurricanes), oil spills, nuclear test sites, Tuskegee
- Barriers: mistrust, lack of funding
- Social determinants: social, economic and environmental (Katrina)
- Improvements: Collaborative partnerships, one-stop model of care

#### Indigenous childbirth: Mixed methods

- Pregnant Indigenous women from rural areas evacuated to hospitals
- Non-native health care providers
- Advisory committee: Indigenous and non-Indigenous government, nonprofits, midwives, and physicians
- Quantitative: Patient Data

#### **Qualitative Date**

- Evacuation stress: no family, need for childcare
- Hospital bureaucracy: long waiting time, repetition of information
- Stereotypes: Nonverbal communication style, "noncompliant, rude"

"The pandemic response reveals with stark and sobering clarity that current paradigms of global health equity are insufficient in counteracting structural oppression." (p. 4)




## How do you address systemic racism in your evaluation in Health Start?


- 1. It is not a relevant concept in our program.

- 6. We are doing this on a regular basis and using it for transformative purposes.


#### Questions: Data Reporting & Use
