CAREWare: An Introduction



How do I access the system?

- Access using a web browser
 - Grantee data are separate, private, and secure
 - Different levels of permissions for users
 - Grantee site administrators can manage their users/permissions
- *Grantees are not required to use CAREWare*

CAREWare: An Introduction



What will it do?

- Primary data collection forms
- Reporting and exports (e.g., monthly aggregate report)
- Case management
- Scoring for standardized assessment scales
- Custom forms and form fields
- Migration of data from another system

- HSMED reporting available **October 1**



- Portal for submission of client-level data
 - Integrated into the EHBs
 - Project Directors can manage users
 - Download submitted data
- Tools & Resources for grantees
 - XML schema & Data Dictionary
 - Training & Technical Assistance



Your Data is Important!



Monthly Aggregate Template

- Updates/Modifications
 - Moderate changes to the behavior-related indicators to better align with DGIS measures & those of other MCHB programs
 - Multiples will now be counted individually in the birth outcomes columns
 - Corrected “sum” formulas
- Data Dictionary
 - MCHB will provide detailed definitions; numerators & denominators; and clarifications, as needed (e.g., monthly numbers vs cumulative YTD numbers)

★ Request for CY2020 Aggregate Data Resubmission

- Grantees will need to resubmit their data from Jan-Jun following the new template & guidance to ensure accuracy & consistency in the HS database



HS Data Collection Forms Updates

- Updates and Modifications Overview
 - The Data Collection Forms (released in Apr) have undergone some minor, but important, changes
 - Discussed in detail in the Deep Dive into HS Data breakout session
- Release of Revised Forms
 - Forms to be shared next week for immediate use
- HSMED2 XML Schema and Data Dictionary to support systems
 - Additional materials will soon be developed and released to assist grantees with data collection & reporting



HS Evaluation



Restating Key Findings & Lessons Learned

- Importance of baseline data
 - Pre-/post-test analyses → outcomes assessment
- The diminishing effects of missing data on results
 - Effects on statistical power
 - Introduction of bias
- Grantee: better data in → more robust results out
- MCHB: stronger evaluation design plan → improved conduct of evaluation study

Those are good numbers.
Don't just throw them away.


Future National Evaluation

- Evaluation Design Contract
 - RFQ should hit the streets soon
 - Award in early September
 - Begin work in mid-September
- Statement of Work
 - 1-year effort
 - Design an evaluation plan for HS program
 - Assess data collection & evaluation capacity of HS grantees
 - Followed by a 3-year implementation of the evaluation activities per the design plan

Future National Evaluation

Why evaluate the HS Program?

- Demonstrate accountability
 - ✓ Government Accountability Office Requirements
 - ✓ Office of Management & Budget Justification
 - ✓ Congressional Justification
 - ✓ Health & Human Services Justification
- Contribute to the body of knowledge
 - ✓ Share successes! And, not-successes!
 - ✓ Inform quality improvement efforts
 - ✓ Add to the evidence-base for some interventions
 - ✓ Provide information for others to use in conducting similar work
